# Recruiters




- Most of the ACCA qualified professionals in India are **employed with the Big 4s or MNCs**. Employers in India have now become aware of ACCA qualification and are hiring them eagerly. Main employers in India for ACCA are Price Waterhouse Coopers, Earnest and young, Deloitte, KPMG, TATA Communications, Embassy Group, Grant Thornton, etc. CA and ACCA members are offered similar job profiles, designation and salary packages.
- India is taking another step **closer towards globalization by introducing Ind-AS** drafted on principles similar to IFRS. ACCA covers IFRS broadly in its syllabus which would definitely give an edge to ACCA members in India.
- With the presence of many **financial KPOs in India**, India has become a major outsourcing hub for accounting and financial functions and ACCA qualified professionals are preferred by the employers for handling these functions.
- In India, average salary offered to ACCA fresher is between **INR 3,50,000 to INR 4,00,000**.



To qualify as an ACCA member, a candidate will be required to complete:



Exams - Attempt and clear 14 exams (ACCA also provides exemptions in some exams depending upon the candidate's previous qualification)



Experience - Record 36 months' experience in a relevant role (candidate can acquire the experience before /during/ after completion of the qualification)



Ethics – Complete the Professional Ethics module.

Examinations are held 4 times in a year i.e. March, June, September & December. However, the papers from F1 to F4 can be taken online around the year at ACCA's Authorized Computer Based Exam centres.

**Knowledge: (F1-F3)** F1 Accountant in Business, F2 Management Accounting, F3 Financial Accounting

**Skills: (F4-F9)** F4 Corporate & Business Law (CL), F5 Performance Management (PM), F6 Taxation (TX), F7 Financial Reporting (FR), F8 Audit & Assurance (AA), F9 Financial Management (FM)

**Professional (Essential; all papers compulsory): (P1-P3)** P1 Professional Accountant (PA) (Essential), P2 Corporate Reporting (CR) (Essential), P3 Business Analysis (BA) (Essential)

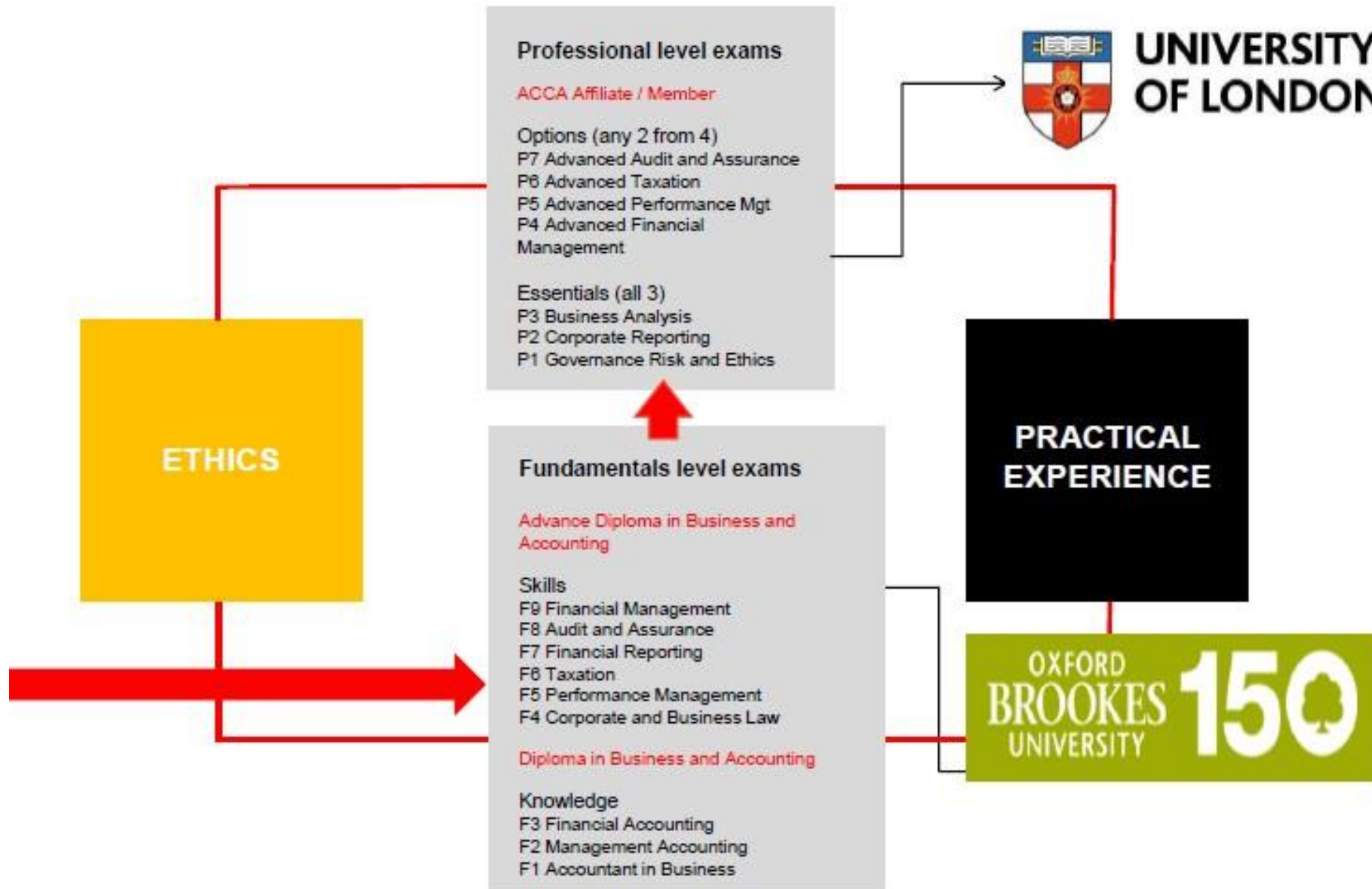
**(Optional; only 2 exams out of 4): (P4-P7)** P4 Advanced Financial Management (AFM), P5 Advanced Performance Management (APM), P6 Advanced Taxation (ATX), P7 Advanced Audit & Assurance (AAA)

# Entry route and exemptions

Commerce graduate	10 Exams (Exemption in F1, F2, F3, F4)	2 years to 2. 5 years
IPCC	9 Exams (Exemptions in F1, F2, F3, F6, F8)	2 years
B.com + IPCC	8 Exams (Exemptions in F1, F2, F3, F4, F6, F8)	1 year
Chartered Accountant (After 2003)	5 Exams (Exemptions in all the papers from F1 to F9)	1 year

*\*\*Candidates who have completed 12th from Commerce stream (pass in 5 subjects including English and Mathematics / Accounts, with a minimum 65% marks in at least 2 subjects and over 50% marks in others)*

# Course information



- ***Can I take the ACCA qualification exams in any order?***
  - You can attempt up to a maximum of four papers per examination cycle. There are two examination cycles per year: 1<sup>st</sup> February to 31<sup>st</sup> July and 1<sup>st</sup> August to 30<sup>th</sup> January. Papers/examinations must be taken in line with the following module (Knowledge/Skills/Professional) order. You can attempt the papers within each module in any order. However, as the syllabus has been developed to progress educationally in the order presented, ACCA recommends that papers within a module are to be attempted in that order only.
- ***How many exams can I take at each exam session under foundations in accountancy?***
  - There is no restriction to the number of exams you may attempt, you will be allowed to appear for as many or as few papers as you like at each exam session. You are, however, recommended to attempt a maximum of four papers in each six-month period.
- ***How do I find out where to go on exam day?***
  - You can log on to your *myacca* account approximately two weeks after standard exam entry closes to download and print your exam attendance docket. This will include the address of the centre where you have been allocated, the papers you have been entered for, the dates for each paper and the desk numbers you should be directed to at the venue. Please remember that you must take your exam attendance docket with you to the examination centre. Please also take official photographic identification such as a passport, driving licence or national identity card.
